Policies and Registration Information

• **Booths** should be ready by 9:30 AM and **MUST** remain in place until 4:00 PM. **No vehicles are allowed in the park. City fine of \$200.**

• **Participants** must provide their own tables, chairs, and protection from sun or rain.

• Professionals as well as amateurs may exhibit with the following conditions. **All arts and crafts must be artisan-made and original*. No kits or commercially made goods will be allowed.**

***Exception:** Upcycled crafts must include original and creative value-added components.

• The Arts Council reserves the right to refuse entry and to remove any item from sale which does not comply.

• **The Arts Council is not responsible for loss, theft, or damage.**

• **No home prepared foods** may be sold without a **Food Service Permit** obtained at the NM Environment Dept. at 2538 Ridge Runner Road. Phone: 454-2800 before August 10.



Non-profits must register, include proof of 501c3 status, be non-political, non-aggressive, pay \$25.00 for space and provide free community information. No sales.

Plaza de los Niños will allow a limited number of entrepreneurial youth between 10 and 17, with hand-crafted work. No tables or canopies, \$5.00 fee. Space for a blanket will be provided.

All participants are expected to help advertise the event.

• **Exhibitors** needing more than a 10' by 10' area must rent two spaces.

• **Registration** for one craft space is \$50 before **August 1**, or \$55 thereafter, and must be paid by **August 20**.

• **Registration** for hot food vendors will be \$110 until **August 1**, or \$120 thereafter and must be paid by **August 20**. We are negotiating electrical connections with the City of Las Vegas. If necessary, can you provide your own generator?

• **Registration** is not complete until the entry form is returned with payment enclosed. When your application is received a space will be assigned and a map e-mailed to show the location. Include space or area preference, but spaces will be assigned in the order that requests are received.

Early paid registration is advised if you wish a specific location.

• **Booth fees** are not refundable after **August 20**. \$5 charge on all refunds.

• **Each booth will** have a responsible person present at the booth all day.

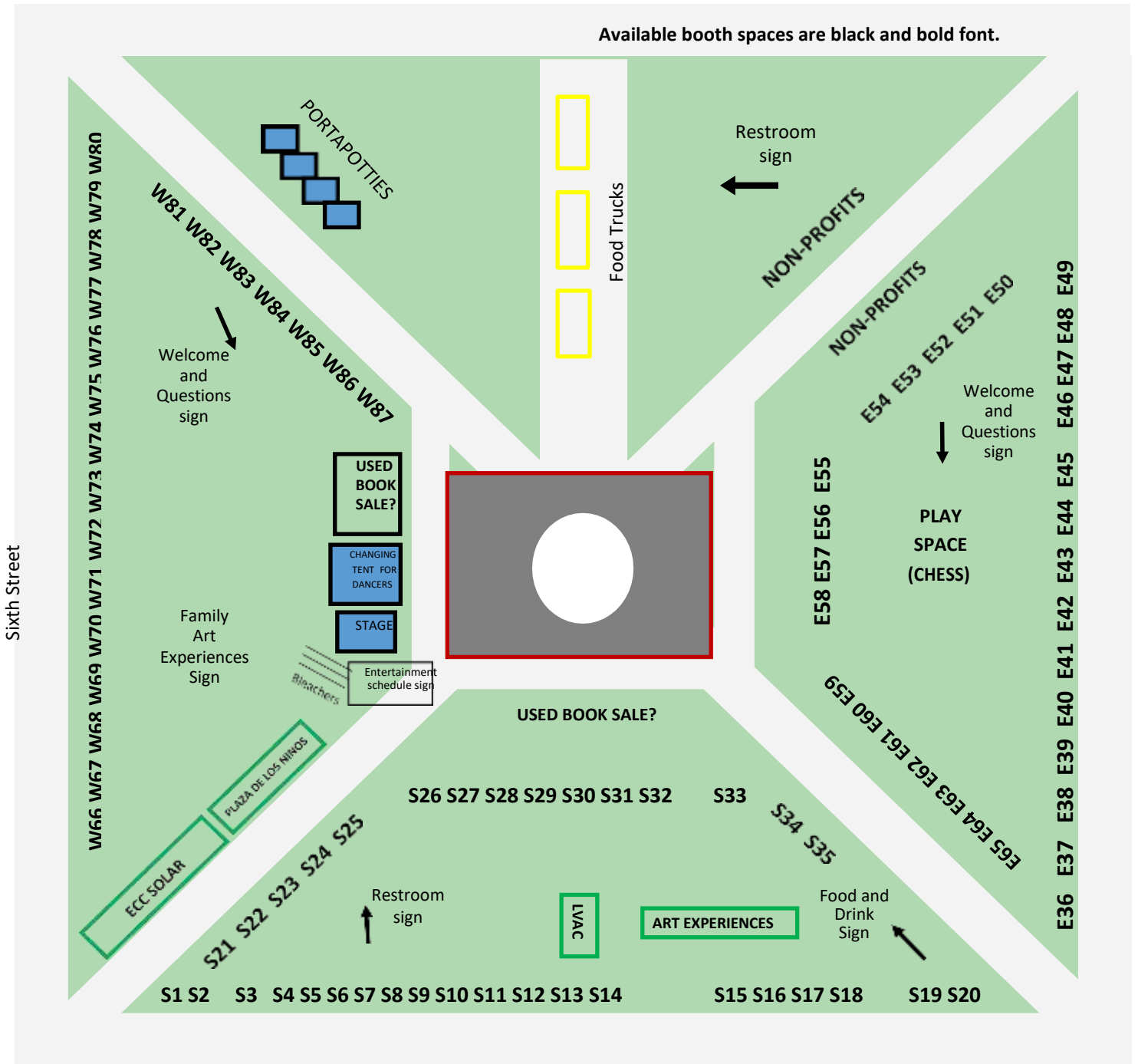
